ATTACHMENT A

Fifth Third Bike the Drive 2020 Vendor/Contractor Insurance Requirement

As a Fifth Third Bike the Drive contracted vendor, we require all vendors, partners and contractors to provide proof of Commercial General Liability Insurance in the amounts as follows:

- \$1,000,000 Each Occurrence
- \$2,000,000 Per event or Location aggregate
- \$2,000,000 Products Completed Operations aggregate
- \$1,000,000 Personal and Advertising Injury Liability
- \$100,000 Damage to property of Others (Fire Legal Liability)
- \$5,000 Medical Payments

In addition, if you have employees, you must provide proof of Statutory (Illinois) Workers Compensation coverage on all employees, contractors and volunteers. This can come in the form of a certificate of insurance.

We also will need an endorsement issued on your Commercial General Liability policy, showing Active Transportation Alliance as an additional insured for the negligence of the contractor, vendor or partner.

Additionally, the Parties agree to indemnify and hold each other harmless including their respective directors, and agents from and against all liability, suits, penalties or actions of every name and description, including without limitation actions for violations of third party rights, including all costs and expenses related thereto, including the cost of the defense thereof, reasonable attorneys fees and court costs arising out or resulting from the act or omission of the other party, its directors, officers and employees, and/or in connection with the performance of this Agreement except to the extent caused by the negligence or willful misconduct of the complaining party. The termination or expiration of the Agreement shall not affect the continuing obligations under this provision.
